No. PER.52/97/153 – In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Meghalaya is pleased to make the following rules to amend the Meghalaya Stenographers Subordinate Service Rules, 2011, namely,

1. **Short title and commencement.** – (1) These rules may be called the Meghalaya Stenographers Subordinate Service (Amendment) Rules, 2011.
(2) They shall come into force from the date of their notification in the Official Gazette.

2. **Substitution of the existing Schedule II.** – For the existing Schedule II appended to the Meghalaya Stenographers Subordinate Service Rules, 2011, the following new Schedule II shall be substituted, namely:-


